March 9, 2009 WADA hereby confirm that we have successfully incorporated all the mandatory articles of the World Anti-Doping Code into Armenian NADO Anti-Doping Rule.

### 4. UNESCO CONVENTION

The UNESCO Approval Committee of the “FUND FOR ELIMINATION OF DOPING IN SPORT” in its ordinary session on 11 April 2010 approved the allocation of USD\$ 19,680 from the Fund to ARMNADO for the implementation of the Development and improvement of administrative procedure of ARMNADO. ## **8. SUPPORT FROM NOC AND GOVERNMENT**

In 2012 the activity of anti-doping department is financed from the budget of the Sport medicine and Anti-Doping Service Republican Centre. The Anti-Doping Service Department has 4 staff – they are chief of Anti-doping service (salary USD\$ 300/month), manager of education program (salary USD\$120/month) and quality manager (salary USD\$120/month) as they do not receive any funding.

Manager of ADAMS system work in NOC (salary USD\$80/month).  
Armenian NOC supported the organization of DCO training.
